Our widespread presence, Utsav is by far the largest player for high security registration plates (HSRP) & transport solutions in India. We have 18 Regional Offices and over 500 representative officers across India, head office at Gurugram.

Utsav is the first Indian Company to get Type Approval Certification (TAC) from the Automotive Research Association of India (ARAI), Pune in 2002 for manufacturing of HSRP's and also is the first company to get Certificate for Conformity of Production (C.O.P.) from ARAI in 2003, for manufacturing HSRP's.

The Company has installed and commissioned its two manufacturing plants for HSRP's in India, one at Himachal Pradesh and other at Kamrup, Assam with a capacity to produce Approx 4.2 Million HSRP Plates in a Month through its three Production line - One line in Gowalthai, Himachal Pradesh and two lines in Kamrup, Assam and fourth one under commissioning for additional capacity of 1.5 million plates per month.

Till date Utsav has got 31 COP Certificates from its Gowalthai, H.P. Plant and 5 COP Certifications from Kamrup, Assam Plant issued from the Testing Agency for Production of High Security Registration Plates with unique features of QR Coding.

UTSAV has so far got exclusive long-term tenders issued by individual States and is Presently operating in 8 States i.e. Himachal Pradesh, Uttarakhand, Delhi, Telangana, Haryana, Bihar, West Bengal and Andhra Pradesh. UTSAV is installing HSRP's on vehicle on exclusive basis under the direct supervision of State Governments and at dealer's end as well as central location's as approved by the state.

Best Logistical Support to-from the Manufacturing Plant in Himachal Pradesh and Assam to the RTOs and Embossing Stations installed in the all the Eight States where the company is currently implementing HSRP Projects.

The Company is having presence at 450 RTO Offices and approx. at 2000 Vehicles dealers.

The company has created 450 Affixation stations in the States and 1500 Manpower to control the process for embossing Stations and affixation stations. The company is having its own controlled embossing units installed in all major Districts of these Eight States to process the HSRP plates as per the registration numbers allotted by the Transport Department through ERP.

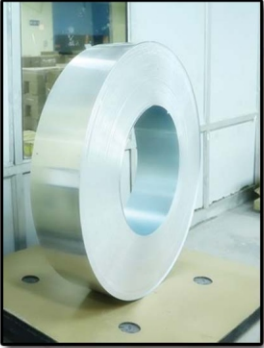
SIZE OF HSRP AS PER CMVR

HSRP Plate Size-wise in Yellow Background

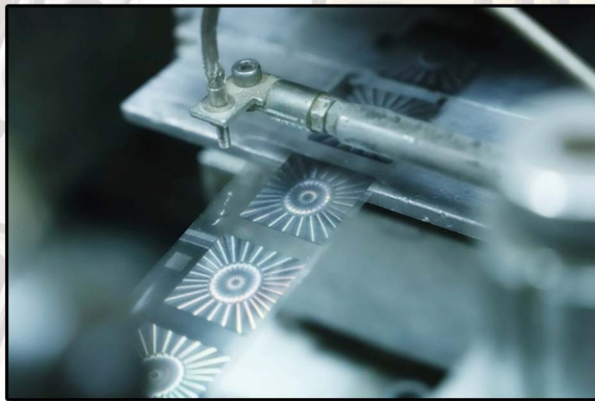
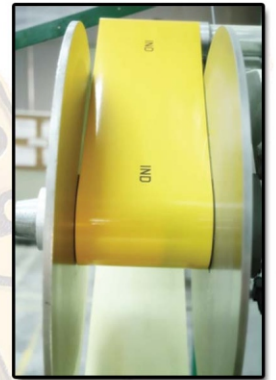

2. Lamination of Aluminium and Retro Reflective Sheet



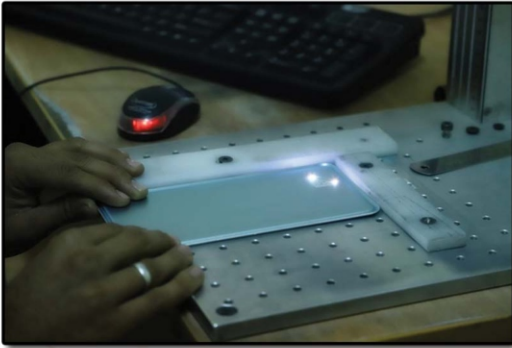

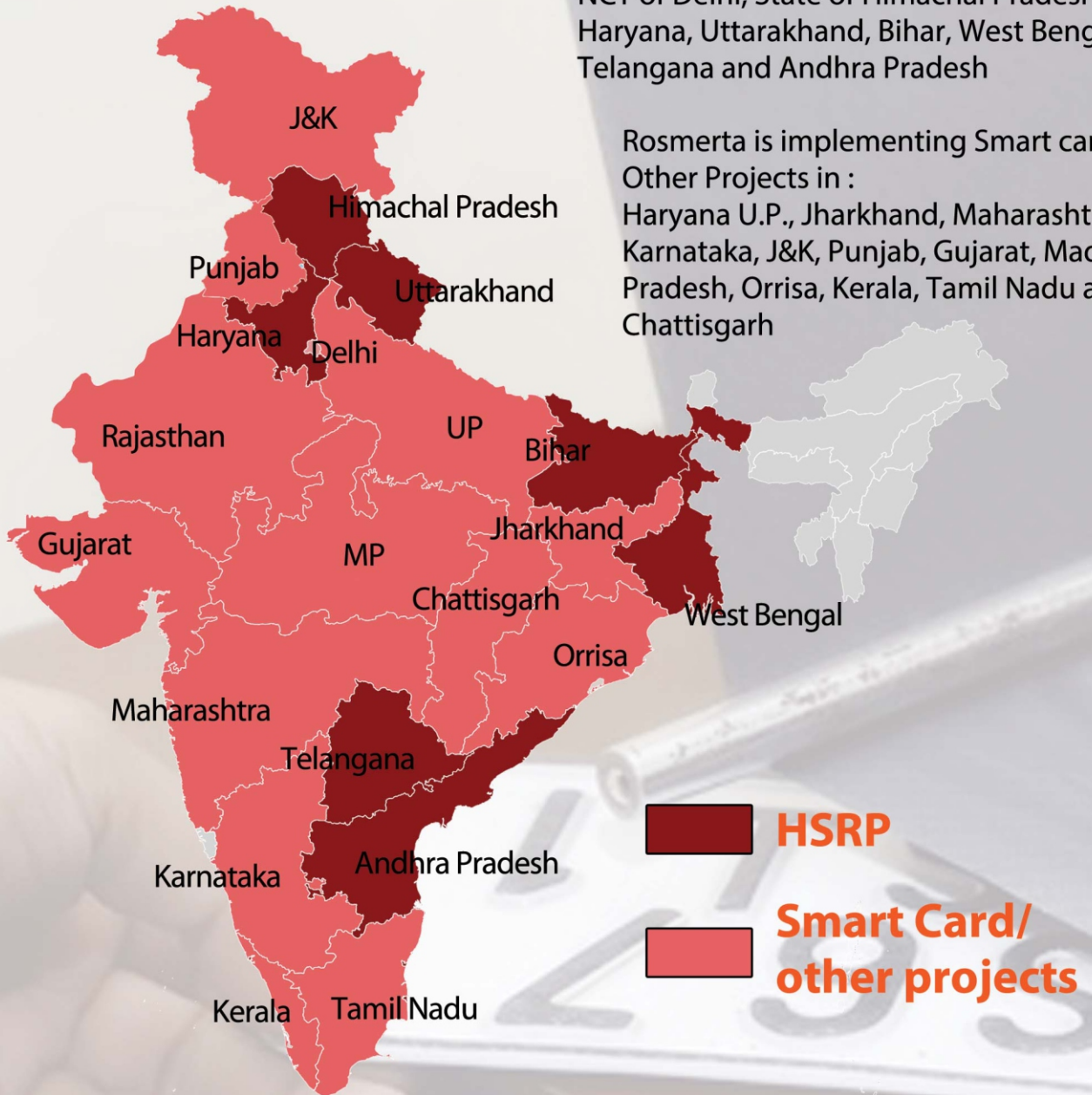
